CORONA PANDEMIC: ECONOMIC IMPLICATIONS FOR THE ICV

We are forced to make significant cost reductions, which means reduced budgets in all areas, including no travel expenses in 2020. For an indefinite period of time, we put the office in short-time work or cut orders for our freelance employees.

Nevertheless, we make sure that you can reach the office at the usual office hours and that basic functions e.g. online communication is maintained and meets current needs.

We rely on the good economic results of our regional conferences in autumn as well as additional income through financial support and donations. Our General Meeting in May and the Management Conference at the end of the year take place online.


