We will organize this year's **Management Conference** in two parts in 2022. too. It is a good time to combine our meeting with your participation in **the General Meeting and the 46th Congress of Controllers**.

We would like to inform you about two innovations since 2022:

a) The **corporate membership will be increased from 4 to 5 people** per membership.

b) the **Controller Magazin** (for German-speaking members) **is available as an app** - i.e. you can also read the CM via an app on a tablet and smartphone. Further information will follow and has already been published by Haufe-Verlag. Due to Haufe strategy changes on the subject of print-digital and from an ecological ICV point of view, our corporate members will only receive one print version of the Controller Magazin since March 2022, as well as digital access for all members of the membership. Individual ICV members will continue to receive print and digital. We are counting on the members themselves to unsubscribe from the print version in the Office. There is no change in the price of membership fees.

Another offer for the CM app will be that companies can obtain multi-user licenses for additional employees through their ICV membership.

And finally, a big thank you for your additional personal financial support in various areas that the ICV was able to experience again this year. We are happy that we can close the year with a balanced result, also due to another tight cost management. We would like to thank everyone for this!
