# Working with controllers from different countires at the International Work Group!

Controllers are engaged more and more as internal consultants than as management accountants. Also their work is more and more international oriented – speaking English as lingua franca of European business. Therefore the ICV has started the international work group, giving experienced controllers and consultants a chance to work for other companies in other countries and learn for their own job.

The ICV speaks to Dr. Herwig Friedag who, with Małgorzata Podskarbi, leads the new Work Group.

#### The International Work Group of the ICV - started as a German-Polish network - will now be realigned. What is it about?

Herwig Friedag: In recent years we have witnessed in our Work Group again and again that in both countries - Poland and Germany - there is a need to communicate and learn from each other that reaches over borders. Our common language in Europe is English and we will be the first ICV European Work Group. We have learned to overcome linguistic and cultural barriers. What is the thematic orientation of the first International Work ICV?Group of the Herwig Friedag: We are all controllers in a world who have changed and continue to change. Nowadays, the methodol-

ogy of the "German controlling" is taught anywhere at the universities, but not the practice!

Therefore, we want to work practically in European companies. We will visit the so-called TARGET COMPANY and get familiar with the local problems - not only in controlling, but also in processes and strategy development and implementation - with topics challenging controllers in the future. Controller is no longer a "number pedant" but is on the way to the management's business partner in the company. With the management of the target company, we will develop tasks for the smaller project groups. In the next six months, each pro ject group will develop solutions. At the next WG meeting, these results will be presented and discussed with the management. The WG acts as a consultant for the target company. Of course, it is then the management's decision how to deal with these proposals. participate? Who can Herwig Friedag: The first Inter-

national Work Group should be a home for experienced controllers and consultants with a certain passion for controlling, broadening their horizons, learning new approaches and sharing practical experiences. What are actually the first steps of the new International WG?

Herwig Friedag: Together with my partner in the WG Board, Małgorzata Podskarbi from Poznan, we are looking for members of the work group and first potential target companies. The dates of our first two meetings have already been signed: June 5-6, 2015 and October 23-24, 2015. The first target company is Nomaxtrading, a Polish company for meat nets – see more at <u>http://</u><u>www.nomaxtrading.eu/</u>. The company, situated in Piekary Śląskie nearby Katowice, Silesia, Poland, is family



owned and is successfully working on many European markets and will expand.

If you know another company that delights to acquire controlling and management support by the International Work Group, please contact me. We still look for a company for next year - we will get in touch with you.

What is expected of the WG participants and what can they expect from the AK? Ig—I quarantee! We would like to thank our supportive target compa-

nies with results useful for them. Therefore, we expect the Work Group members, both controllers and consultants, minimum 5 years of practical experience and appropriate English knowledge, because all discussions of the Work Group are conducted in English. In addition, participation in

the two WG meetings will be mandatory, otherwise, the place in AK is free for the others. The WG members - or their companies - cover travel the expenses. So that controllers could be attractive partners of the management in their companies, they should collect experiences as internal consultants in as many companies as possible. This is possible in the International Work Group!
